The meeting was held at the USDA/SWCD Meeting Room and via Zoom Video Conferencing. Kevin Wilde, Secretary, called the meeting to order at 9:25 a.m. Kevin completed a roll call of all supervisors and staff and welcomed guests.

Ricky made a motion, seconded by Greg to approve the revised agenda. All in favor, motion carried.

Ricky made a motion, seconded by Greg to approve the March 16, 2023, meeting minutes. All in favor, motion carried.

Barb reviewed the March 2023 Financial Report. Kevin made a motion, seconded by Greg to approve the March 2023 Financial Report. All in favor, motion carried.

All in favor, motion carried.

Peter reviewed changes to the Pennington SWCD Non-Structural Land Management Program Policy. Three of the higher priority changes include:

- 1. Switching contract length to a minimum of one year and maximum of three years with the maximum number of contracts not to exceed six years in length.
- 2. Increasing the cover crop species payment rates.
- 3. Removing the paragraph delegating the District Manger to sign contracts and supporting documentation. That will be the responsibility of the Board.

Greg made a motion, seconded by Ricky approving the requested changes in the Pennington SWCD Non-Structural Land Management Program Policy. All in favor, motion carried.

Larissa stated the city of Thief River Falls does not have staff trained to administer the Wetland Conservation Act and the SWCD staff has been administering WCA for the city. Currently, there is no formal resolution or agreement between the city and SWCD to administer WCA. The Board agreed a formal agreement, or resolution, needs to be

established between the city of Thief River Falls and the SWCD for administration of WCA. Ricky made a motion, seconded by Greg to pursue a resolution between the city of the Thief River Falls and Pennington SWCD to administer WCA within city limits and charge billable rates for the service. If the city does not agree, BWSR involvement may be required. All in favor, motion carried.

Motion by Ricky, seconded by Kevin approving the Memorandum of Agreement between the Pennington SWCD and the Pennington County Sportsmen's Club for a Conservation Corps crew to remove buckthorn at the Pennington County Sportsmen's Club site. The project is funded by a Clean Water Fund Grant. All in favor, motion carried.

Two potential Long Lake campers' paragraphs were read to the Board. Motion by Kevin, seconded by Greg to sponsor Owen Ranum and Jace Sands at Long Lake Conservation Camp on July 9-14. All in favor, motion carried.

Ricky made a motion, seconded by Kevin approving the NRCS Agreement for four computer seats and the telephone systems. All in favor, motion carried.

Employee reports were available for review.

NRCS report was available for review.

Farm Bill Biologist report was available for review.

Grant Nelson's report was available for review.

Three pictures were submitted for April's photo contest. The Board chose the photo of the northern lights submitted by Miranda Carlson as the winner.
