Matt Fischer gave an overview of the 2024 Legislative Session.

• The Request for Proposal is open for Clean Water Fund (CWF) grants and includes categories for projects and practices, accelerated implementation, drinking water, and multipurpose drainage management. There were legislative changes to WCA that apply NRCS Wetland Determinations for agricultural exemptions (drainage) on prior converted land.

Soil Health staff, Gabe Okins (Shared Soil Health for the North Pod) and Travis Nelson (Red Lake County SWCD Conservation Technician), introduced the new Soil Health partnership.

The 2024 SWCD Aid Resolution was presented and discussed. Ricky made a motion, seconded by Kevin to approve the 2024 SWCD Aid Resolution. All in favor, motion carried.

Kevin made a motion, seconded by Ricky to approve District staff to attend BWSR Academy October 29-31. All in favor, motion carried.

Kevin & Beth Ballard were selected as the 2024 Rural Beautification winners.

Ricky made a motion, seconded by Kevin to authorize the District Manager to enter into the Soil Health Delivery Grant in the amount of \$80.000. All in favor, motion carried.
